Firing of live ammunition in the form of service, practice, blank, pyrotechnics will/will not (see Note 1) take place and troops using the area will be instructed to take every care to:


- a. leave your property clean and tidy;
- b. avoid damaging roads, fences, timber, pasture, crops etc;
- c. ensure that all gates are closed after use;
- d. avoid injuring or frightening livestock;
- e. recover unexploded ammunition and pyrotechnics; and
- f. carry out, as far as possible, any special requirements you may stipulate in appendix 1.

If you should find any unexploded or unused ammunition or pyrotechnics on your land after the troops have departed, it is important that you do not handle the items in case of causing injury to yourself. You are requested to notify this Unit if you find any such ammunition or pyrotechnics and arrangements will be made for their safe recovery.

In the event of any damage being done to your property by reason of the use of the land you are entitled to claim compensation. Should we identify or know of any damage, it will be reported to you. In any event, an officer will visit you after the activity.

At the conclusion of the military training on your property a clearance certificate will be need to be completed (Appendix 2 to this Annex). Should you wish to claim compensation, the claim must be made personally on the enclosed form (Appendix 2) and be forwarded to the above address within 72 hours. It is advised that a private valuation of the damages by valuers will not be accepted.
